

Terms of Use Hoffmann Connected Tools Windows App.

1. Scope

3. Provision of the Software, User License and Rights of Use

The software is made available for download by Hoffmann on the website. The chargeable license to use the software is provided by Hoffmann via a USB dongle.

Upon full payment of the purchase price, you will receive the rights of use described in the software (hereinafter referred to as "License") in accordance with the following regulations. The Software is provided to you by Hoffmann solely on the basis of these Terms of Use.

With the purchase of the USB dongle, we grant you a non-exclusive, non-transferable license for the use of this software. In particular, no right to copy and/or distribute the license is granted.

Purchasing a valid license entitles you to use the On-Premise software on your server.

The use of the software is not limited to a certain number of systems. You are entitled to use the software yourself and by your employees for your business activities.

The software may not be rented, loaned or leased. In addition, you may not make any changes to this software. The software may not be reverse engineered or translated. Program parts must not be removed from the software. You may not disclose or make available to third parties any access codes, passwords or license keys for the software or its use.

It is your responsibility to ensure that the specified system requirements (Windows 10 or later, free USB slot, .NET Framework 4.8 or later) for using the software are met.

You can download the latest software updates from our website. You are obliged to inform yourself about the availability of new updates.
