

Privacy Policy for the Hoffmann Connected Tools App

We are delighted that you are interested in our Hoffmann Connected Tools app (hereinafter referred to as the "App"). We attach great importance to the protection of your privacy. We consider it part of a company's responsibility to protect information and data entrusted to it. To ensure that you feel comfortable when using our App, when processing your personal data we strictly comply with the provisions under the law. In this privacy policy, we would now like to inform you in detail how we handle your data.

This privacy policy applies in addition to our general privacy policy.

1. Who is responsible for the processing of my data?

The controller for the processing of your data when you visit this website is Hoffmann Engineering Services GmbH, Haberlandstr. 55, 81241 Munich.

2. When does the App record data concerning you and on what legal basis?

When you download the App, the necessary information will be transferred to the App Store, particularly the user name, e-mail address and customer number of your account, the time of the download, payment information and the individual device code numbers. We have no influence over that data collection and are not responsible for it. We only process the data if it is necessary for downloading the App onto your mobile end device.

You can object to the data processing with effect for the future by sending us an e-mail <u>at dataprotection@hoffmann-group.com</u> or by making the appropriate setting in the App.

3. How long is your data stored?

We store your data only as long as necessary for the achievement of the purpose for which it was collected (for example in connection with a contractual relationship), or insofar as this is legally required.

4. What data protection rights do you have?

You have a right with respect to Hoffmann Engineering Services GmbH and the Hoffmann group companies, subject to the respective statutory conditions, to be provided with information (Article 15 GDPR), to rectification (Article 16 GDPR), to erasure (Article 17 GDPR), to restriction of the processing (Article 18 GDPR) and to data portability (Article 20 GDPR). You also have a right to lodge a complaint with a data protection supervisory authority (Article 77 GDPR).

If you have granted consent to Hoffmann SE or a Hoffmann group company you may revoke it at any time with effect for the future by e-mail, fax or letter: Hoffmann Engineering Services GmbH, Haberlandstr. 55, 81241 Munich, fax: +49 89 839189, e-mail: dataprotection@hoffmann-group.com.

If Hoffmann Engineering Services GmbH processes your data on the basis of a balancing of interests, you may object to the processing. If you lodge an objection, we will no longer process your data unless the controller company can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or the processing serves the purpose of the establishment, exercise or defence of legal claims.

5. additional function Connected Manufacturing

A function is also integrated in the app which requires the login to Connected Manufacturing (CM). The contractual data protection provisions for the use of CM apply (terms of use and appendices).
