

## Data Protection

We are pleased that you are interested in our website. Protecting your privacy is very important to us. For Hoffmann, guarding the information and data entrusted to us is part of our corporate responsibility. To make sure that you feel safe when visiting our web pages, we adhere strictly to the statutory provisions when processing your personal data. Below we will provide you with detailed information about how we handle your data.

### 1. Who is responsible for processing my data?

#### 1.1. When visiting this website

The responsible party (controller) when processing your data during your visit to this website is Hoffmann SE, Haberlandstr. 55, 81241 Munich.

#### 1.2. For contractual performance and services

Some of the services presented to you on this website are not provided by Hoffmann SE itself, rather by the Hoffmann Group company responsible for the particular services and offerings at local level. The competent Hoffmann group company will be responsible for processing your personal data when you commission the services or offerings of a local Hoffmann Group company via this website (e.g. placing an order, services, customer support).

Hoffmann SE is always responsible for orders and service requests from consumers.

In most cases the Hoffmann Group company responsible at the place of delivery will be responsible for orders and service requests from corporate customers. The details provided in the order and contractual documents are authoritative for orders. In most cases the Hoffmann Group company responsible for the specific location will be responsible for services and enquiries with reference to a particular location.

Where necessary, Hoffmann SE will transfer the data collected from you to the Hoffmann Group company responsible for you if you order performances and services from Hoffmann Group companies via this website.

### 2. When does Hoffmann collect data about you?

#### 2.1. When visiting the website

We collect data to a limited extent in order to accept and process your orders and to send you offers that reflect your needs. You can visit our web pages without providing personal details. We save technical access data in server log files, e.g. the name of the requested file, the data and time of access, the data volume transferred and the Internet service provider. This data is used exclusively to ensure smooth operation of the website and to improve our offering.

We collect personal information in particular

- when you place an order in our web shop
- when you register a personal customer account
- when you subscribe to our newsletter
- when you use our contact and service enquiry form
- when you contact us by email.

The individual input forms state which information is collected. We use the data you provide for contractual performance, to provide the services and to process your enquiries.

#### 2.2. Newsletter Subscription

You have the possibility to order our newsletter, in which we inform you regularly about special offers. To order our newsletter we use the so-called double opt-in procedure, i.e. we will only send you the newsletter by e-mail if you confirm in our notification e-mail by clicking on a link that you are the owner of the e-mail address provided. If you confirm your e-mail address, we will save your e-mail address, the time of registration and the IP address used for registration until you unsubscribe from the newsletter. The sole purpose of storing your e-mail address is to send you the newsletter and to provide proof of your registration.

**You are entitled to revoke your consent at any time, effective for the future. You may unsubscribe from our newsletter at any time, either by sending a message to the contact address above or by clicking on the unsubscribe link in the email.**

The legal basis for data processing is your consent pursuant to Art. 6 Paragraph 1 Point a GDPR.

### 2.3. Contact us

You have several possibilities to get in contact with us. These include the contact form and contacting us by e-mail. In this context we process data exclusively for the purpose of communicating with you. The legal basis is Art. 6 Paragraph 1 Point b GDPR. The data collected by us when using the contact form will be automatically deleted after your inquiry has been completely processed, unless we still need your inquiry to fulfil contractual or legal obligations.

We also use a live chat of the company Userlike UG (haftungsbeschränkt), Probsteigasse 44-46, 50670 Cologne, Germany. As part of the cooperation, we have concluded a contract processing agreement with Userlike UG in accordance with Art. 28 DSGVO. You can use the live chat like a contact form to chat with our employees almost in real time. **To answer your questions quickly, we use the Live Preview setting.** When starting the chat, the following personal data is collected: Date and time of the call, browser type/version, IP address, operating system used, URL of the previously visited website, amount of data sent.

And if specified: First name, last name, and email address.

As soon as you are logged in with your customer account, the following personal data are processed at the start of the chat, depending on the information in the customer profile, for faster processing of your request: name, e-mail address, telephone number, cell phone number, address, title, customer number.

Depending on the course of the conversation with our employees, further personal data may be collected in the chat, which will be entered by you. The nature of this data depends largely on your request or the problem you describe to us. The purpose of processing all this data is to provide you with a quick and efficient way to contact us and thus improve our customer service.

By going to <https://www.hoffmann-group.com/DE/de/hom/>, the chat widget is loaded in the form of a JavaScript file from AWS Cloudfront. The chat widget technically represents the source code that runs on your computer and enables the chat.

In addition, we store the history of live chats for a period of 12 months. This serves the purpose of sparing you extensive explanations about the history of your request under certain circumstances, as well as for consistent quality control of our live chat offer. The processing is therefore permitted pursuant to Art. 6 (1) (f) GDPR. If you do not wish this, you are welcome to inform us of this using the contact details listed below. Stored live chats will then be deleted by us immediately.

The storage of chat data also serves the purpose of ensuring the security of our information technology systems. This is also our legitimate interest, which is why the processing is permitted under Art. 6 (1) lit. f GDPR.

### 2.4. Webinar / Whitepaper

Our webinars are computer-based and software supported. We use the GoToWebinar software from LogMeIn Ireland Limited, Bloodstone Building Block C, 70 Sir John Rogerson's Quay, Dublin 2, Ireland. LogMeIn, Inc. is responsible for providing this service and the associated data processing. In order for the webinar to take place, we transmit your login and customer data to LogMeIn Inc. In particular, the following data is processed: Name, surname, email address, webinar ID.

We have a contract with LogMeIn to deliver this service and fully implement the strict requirements set down by the German data protection authorities when using GoToWebinar. Data transfer to the USA is done in accordance with decision (EU) 2016/1250 of the European Commission (EU-US data privacy shield).

Personal data you provide is processed for the purposes of preparing and implementing the webinar that you wish to participate in. This processing is required in order to fulfil the contract according to Art. 6 (1) (b) GDPR.

Your personal data will be deleted upon termination of the contract and in accordance with the legally required data retention obligations.

If you wish to participate in one of our free webinars or download a free whitepaper or similar publication, you must subscribe to our newsletter. Subscribing to the newsletter and sending your email address is considered as compensation for provision of the free webinar / whitepaper.

At the same time, personalised profiles are created in order to provide you with better online offers relating to your personal interests. The legal basis for processing your data in this regard is Art. 6 (1) (a) GDPR.

The information under 2.2 Newsletter subscription also applies.

## 2.5. Evaluation of your order

After a successful order process, you have the opportunity to leave a rating including comments on the previous order process. In this context, we process data exclusively for the purpose of improving our services.

For this purpose, we use the service provider SurveyMonkey (SurveyMonkey Europe UC, 2nd Floor, 2 Shelbourne Buildings, Shelbourne Road, Dublin, Ireland), a web service for creating and evaluating online surveys.

When you voluntarily participate in this survey, SurveyMonkey collects information about the device and application you use to take the survey. This includes your IP address, operating system version, device type, system and performance information, and browser type. If you are taking the survey through a mobile device, SurveyMonkey also collects the device's UUID. SurveyMonkey also uses so-called third-party tracking services, which in turn use cookies and page tags (also known as web beacons) to collect usage data and user statistics. If participation is voluntary, SurveyMonkey also collects first name, last name and phone number as part of the one-time survey for contact purposes. We have no control over the amount of data collected by SurveyMonkey. The legal basis is Art. 6 para. 1 lit. f DSGVO. Hoffmann has a legitimate interest in integrating the rating function into its ordering process in order to further develop its services.

You can object to data processing within the scope of the rating function at any time.

The data we collect when using the rating function will be automatically deleted after 3 months, unless we still need your data to fulfil contractual or legal obligations.

## 3. How does Hoffmann use the data?

### 3.1. For the performance of contractual obligations (Art. 6 Paragraph 1 Point b GDPR)

Hoffmann uses your data for the purpose of offering you the best possible shopping and service experience. In doing so we treat your data responsibly. In particular Hoffmann SE and the Hoffmann Group companies use your data to

- fulfil your order
- process your service enquiry

Where a Hoffmann Group company is responsible for your order or service enquiry, we will pass on our data to the Hoffmann Group responsible for you.

Where it is necessary for the delivery of ordered products, we, i.e. the responsible Hoffmann Group company, will pass on your data to the transport company entrusted with shipping for the purpose of contractual performance. Depending on the payment service provider you select in the order process, we, i.e. the responsible Hoffmann Group company, will pass on the payment data collected for the fulfilment of payment to the banking institution authorised for payment or to the payment service provider, i.e. the payment service, commissioned by us. In some cases the selected payment service providers will collect this data themselves when you register an account with them (e.g. for payment by PayPal). In this case you will be requested to log in to the payment services provider during the order process. The Privacy Policy of the particular payment service provider will apply in these cases.

### 3.2. Through balancing of legitimate interests (Art. 6 Paragraph 1 Point f GDPR)

We are also entitled to use your data where it is necessary for the purposes of our legitimate, usually commercial, interests or the legitimate interests of third parties, whereby we will process the data in a pseudonymised or anonymised form where possible. This takes place for the following purposes:

- to monitor and improve the efficiency and legal compliance of business processes
- to check creditworthiness
- to monitor, optimise and enhance services and products
- to conduct advertising (e.g. postal advertising, re-targeting), as well as for market and opinion research
- to exercise legal claims and for defence in legal disputes
- to detect, prevent and clarify criminal acts
- to guarantee the security and operability of our IT systems
- Implementation of customer satisfaction surveys by e-mail

### 3.3. Based on your consent (Art. 6 Paragraph 1 Point a GDPR)

Where you have given consent to the processing of your data, processing shall be lawful on the basis of consent in each case. This applies in particular to any consent you provide to contact for advertising purposes by telephone or email.

### 3.4. For the fulfilment of legal obligations (Art. 6 Paragraph 1 Point c GDPR)

We are required to comply with a number of legal obligations, e.g. statutory retention periods for business records and provisions under export law.

## 4. Transfer of your data

Where it is necessary to commission the services of external providers (hosting providers, shipping services, etc.) for the operation of this website or for performances by the Hoffmann Group companies, or where a different Hoffmann Group company is responsible for processing, the respective enterprise will only receive your data in the scope that is necessary for the fulfilment of their task and function.

Where this service provider and the Hoffmann Group company process your data outside of the European Union, your data may be transferred to a country that does not uphold the same data protection standards as the European Union. We ensure in these cases that the recipient of your data is required by contract or by other means to adhere to a data protection standard equivalent to that of the European Union.

## 5. How does Hoffmann use your data for postal advertising?

Insofar as it is permitted by law, Hoffmann SE, i.e. the Hoffmann Group company responsible for you, reserves the right to process your data for the purpose of direct postal advertising, even without your consent. This includes the analysis of your data (e.g. master data, order data, access data) to identify your potential interest in our products and services. Analysis is conducted using statistical methods based on current customer data and generally available insight into our customers. The results are used to contact you in a targeted manner to reflect your needs and to send you relevant offerings.

This serves to safeguard our legitimate interests, which outweigh the interests of our clients, in addressing them in advertising in accordance with Art. 6 Paragraph 1 Point f GDPR.

**You are entitled to object to the processing of your data for this form of advertising at any time. This applies also to profiling insofar as it is associated with this form of direct advertising. You may send your objection to the contact details above, i.e. to the Hoffmann Group company responsible in your case.**

## 6. How does Hoffmann use your data for voucher campaigns?

Hoffmann customers benefit from various voucher and discount offers. If you have agreed to the promotional use of your data, we will inform you about voucher campaigns in the newsletter, by e-mail or by post. In addition, Hoffmann has a legitimate interest in sending personalised vouchers and discounts to existing customers in accordance with Art. 6 Paragraph 1 Point f DSGVO. We process your data within the scope of your voucher redemption. If you redeem personalised voucher codes in your customer account in the web shop, the data will be merged with your personal data.

## 7. When does Hoffmann conduct creditworthiness and score checks?

Where Hoffmann SE, i.e. the Hoffmann Group company responsible for you, incurs costs in advance, e.g. in the case of ordering on account, the respective company reserves the right, for the protection of its legitimate interests, to obtain an identity and creditworthiness check from a specialised services company (credit agencies), i.e. to predicate the agreement to certain terms of payment on the completion of a creditworthiness check. The creditworthiness information may contain probability values (score values) that are calculated according to scientifically substantiated, mathematical and statistical methods and whose calculation may involve the inclusion of other address data. We use the information we receive on the statistical probability of payment default to make a balanced decision on the establishment, execution or termination of the contractual relationship. Your legitimate interests are considered in accordance with the statutory provisions.

## 8. Why does this website use cookies?

We use cookies on some pages to make your visit to our website more attractive and to enable the use of certain functions. Cookies are small text files that are placed on your device. Some of the cookies we use are deleted at the end of your browser session, so when you close the browser (session cookies). Other cookies remain on your device and allow us to recognise your browser on your next visit (persistent cookies). You can adjust your browser settings to receive an alert when a cookie is placed and to decide individually whether to accept, to accept cookies only in certain cases or to block cookies altogether. You may not be able to use all of the website functions if you block cookies.

Most browsers (refer to the Help tab in the browser taskbar) can be adjusted to block new cookies, to send you an alert when a new cookie is placed or to disable all cookies you have received. Refer to the operating instructions of your smartphone, tablet and other mobile or stationary devices to learn more about adjusting your settings.

Our cookies do not store sensitive data like passwords, credit card data or similar. They do not damage your device and do not contain viruses.

This is achieved by analysing your behaviour based on the products in our shop that you have shown an interest in. None of the data will be disclosed to third parties. This data is collected using so-called "cookies". Cookies are small text files that are stored on your computer or mobile device. These cookies enable us to recognise your browser when you revisit our website. ### 10.2. Web analysis service by Google (Universal) Analytics

This website uses Google (Universal) Analytics, a web analytics service provided by Google Ireland Limited, Gordon House, Barrow Street, Dublin 4, Ireland ([www.google.de](http://www.google.de)). Google (Universal) Analytics uses "cookies", which are text

### 10.5. Campaign Manager (formerly DoubleClick by Google)

Our website uses online marketing tool Campaign Manager by Google Ireland Limited, Barrow Street, Dublin 4, Ireland ("Google"). Campaign Manager uses cookies to serve ads that are relevant to users, to improve campaign performance reports, or to prevent a user from seeing the same ads multiple times. Google uses a cookie ID to determine which ads are running in which browser and can prevent them from being displayed multiple times. In addition, Campaign Manager can use cookie IDs to track so-called conversions related to ad requests. For example, if a user sees a Campaign Manager ad and later uses the same browser to go to the Hoffmann's website and buy something there. The data collected in this context may be transferred by Google to a server in the USA for evaluation and stored there. In the event that personal data is transferred to the USA, Google has submitted to the EU-US Privacy Shield.

Due to the marketing tools used, your browser automatically establishes a direct connection to the Google server. We have no control over the extent and further use of the data collected through the use of this tool by Google and therefore inform you according to our knowledge: By integrating Campaign Manager, Google receives the information that you have the corresponding part of our website or click on an ad from us. If you are registered with a service provided by Google, Google may associate the visit with your account. Even if you are not registered with Google or have not logged in, there is a chance that the provider will find and store your IP address.

You can prevent participation in this tracking process in several ways: a) by adjusting your browser software accordingly, in particular, the suppression of third-party cookies will prevent you from receiving any third-party ads; b) by disabling the cookies for conversion tracking, by setting your browser to block cookies from the domain <https://adssettings.google.com/authenticated>, whereby this setting will be deleted if you delete your cookies; c) by permanent deactivation in your browsers Firefox, Internet Explorer or Google Chrome under the link <http://www.google.com/settings/ads/plugin>. We point out that in this case you may not be able to use all the features of this offer in full.

## 10.6. Commerce Connector - Conversion Tracking

We use conversion tracking software made by Commerce Connector GmbH, Deckerstrasse 41, 70372 Stuttgart, Germany. Commerce Connector provides a Buy Now button that links to suppliers whose products we sell.

When you click on the link, our partner, Commerce Connector GmbH, will store a cookie on your device for a limited period. If you make a purchase in our webshop during this period, Commerce Connector can access the cookie. This ensures that we and our suppliers receive information concerning your purchases. As a rule, this cookie becomes invalid after seven days.

Commerce Connector uses the acquired purchasing information to create anonymised sales statistics for our products that are sold via a link and subsequently provides us with these statistics. These statistics do not contain any personal data or allow us to identify any individual users. We only receive anonymised sales/order content.

If users do not agree to this data being processed, they can prevent the cookie from being installed by adjusting their browser settings accordingly. ## 10.7. Kameleoon

Our website uses the testing and web analysis service provided by SAS Kameleoon, 2 rue de la Chaussée d'Antin, 75009 Paris, France. Using this program enables us to analyse user behaviour in order to compile website activity reports so that we can regularly improve our services.

Cookies linked to pseudonymised IDs are set for the purpose of analysis. Your IP address is fully anonymised for this purpose and is not stored. Information generated by the cookie concerning your use of this website is stored in an aggregated and pseudonymised form. Kameleoon will not combine the IP address transmitted to the Kameleoon service by your browser with any other data.

You can prevent cookies being stored by making the appropriate settings in your browser software. You can also deactivate Kameleoon tracking at any time by clicking on Cookies in the footer of this website and adjusting the settings accordingly.

## 10.8. Microsoft Dynamics 365

On our website and for e-mail marketing, we use the marketing automation system Microsoft Dynamics 365 Marketing from the provider Microsoft Corporation (Microsoft Deutschland GmbH, Walter-Gropius-Straße 5, 80807 München) – hereinafter "Microsoft" – in order to conduct marketing campaigns, for analysis purposes, as well as to suitably address customers and potential customers. The processing of data takes place within the European Union.
